### EMPLOYEE SHARE PLAN ISSUE

Good Drinks Australia Ltd (**ASX: GDA**) advises that in accordance with the Company's Executive and Employee Share Plan 100,000 shares have been issued to eligible employees.

This issue was made to employees that the Board has deemed key employees and instrumental in the future direction of the business.
